APPROVING MAP OF SARN-SMITH SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, Registered Civil Engineer, and entitled "SARN-SMITH SUBDIVISION Being a subdivision of a portion of Lot 5, in Pueblo Lot 255, in The City of San Diego, County of San Diego, State of California, according to Referee's Partition Map filed in the action of Morena Company, a corporation, vs. Franklin Steel, Jr., Case No. 3475, filed in the Superior Court of the County of San Diego.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: portion of Asher Street, for public purposes, and said portion of street is hereby declared to be portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the open space easement over portions of Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as

heretofore stated; and the open space easement as granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
