That the City Manager be, and he is hereby authorized and empowered to execute for, and on behalf of said City, an agreement with CHILDREN'S HOME SOCIETY OF CALIFORNIA for the purpose of providing consistent care within a family setting for children in Southeast San Diego and Linda Vista, and to give supportive services to their parents and to the day care parents involved as part of the City-County program of using Revenue Sharing Funds for the operation of human care services as approved by Resolution No. 208955 on October 2, 1973, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 746114.
