
Adopted on JAN 17 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City an agreement with MISSION BAY LESSEES' ASSOCIATION, a nonprofit California corporation, for the operation of an advertising and promotional program designed to increase the year-round use of Mission Bay Park, and to gain national recognition of Mission Bay Park as an aquatic recreational area, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 746130.

That the expenditure of \$32,500 out of Transient Occupancy Tax Unappropriated Reserve Fund 224 is hereby authorized solely and exclusively to provide funds for the services stated above.
