

RESOLUTION NO. 209691 JAN 17 1974

WHEREAS, by Resolution No. 151791, dated December 18, 1958, this Council declared the following City street to be a one-way street:

GIFFORD WAY for southerly-bound traffic  
between Langmuir Street and Comstock Street;

and

WHEREAS, The City of San Diego has now received a request from the San Diego City Schools to remove the one-way street pattern; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that portion designated of the following City street is hereby declared to be a two-way street:

GIFFORD WAY, between Langmuir Street and  
Comstock Street.

2. That the installation of the necessary signs and markings is hereby authorized to be made on said street.

3. That the regulations hereinabove imposed shall become effective upon the installation of such signs and the removal of the one-way street signs.

4. That Resolution No. 151791, dated December 18, 1958, which established the above referenced one-way street be and the same is hereby rescinded.
