Madelyn L. Leibold	WATER UTILITIES DEPARTMENT	\$795	It had been long established practice of the New Services Section to assign house numbers in new subdivisions after the tentative map was approved. Numerous changes required renumbering several times. This took a great deal of time of City personnel, and several outside organizations. The suggestion to number houses only after final approval of the subdivision has been given has been in effect for a year. This saves \$7,953 worth of time for the City alone.
Larry H. Smith	POLICE DEPARTMENT	\$485	Sgt. Smith was concerned about the number of occasions Police personnel had to hood parking meters during construction projects, and the loss of meter revenue. His suggestion to charge for taking the meters out of service temporarily has been adopted for a total revenue to the City of \$4,850 per year.
Herbert E. Michaels, Jr.	PUBLIC WORKS DEPARTMENT Buildings Division	\$280	This Electrician proposed the installation of electrical interrupters on the chemical feed system for the cooling system in C.A.B. and C.O.B. This has been found to save \$2820 worth of the chemical through better control of the flow.
