

RESOLUTION NO. 209703 **JAN 22 1974**

WHEREAS, by deed recorded May 7, 1959 as Document No. 91431, Book 7647, Page 475, in the office of the County Recorder, The City of San Diego conveyed portions of Pueblo Lots 1325, 1331, 1332, 1333, 1334, 1336, 1337, 1338, 1339 and 1340 to the State of California for Torrey Pines State Park; and

WHEREAS, The City of San Diego reserved the right to use portions of Pueblo Lots 1336 and 1339 for municipal sewage disposal purposes for the Sorrento Valley Sewage Treatment plant; and

WHEREAS, as of September 1, 1972 the treatment plant was shut down and abandoned by the Water Utilities Department; and

WHEREAS, the State of California Department of Parks and Recreation has requested the City to quitclaim its interest in and to said portions of Pueblo Lots 1336 and 1339; and

WHEREAS, this transaction is exempt from the provisions of the California Environmental Quality Act of 1970 in accordance with Section III.H. of the City Guidelines for Implementation of said Act; and

WHEREAS, the City Manager recommends that said portions of Pueblo Lots 1336 and 1339 be quitclaimed to the State of California to be used for park purposes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that certain real property right described in that form of quitclaim deed on file in the office of the City Clerk as Document No. 746139, be, and the same is hereby authorized to be quitclaimed to the STATE OF CALIFORNIA.

2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 746139, quitclaiming to the STATE OF CALIFORNIA, portions of Pueblo Lots 1336 and 1339, as more particularly described in said form of quitclaim deed.

3. That the City Clerk of said City is hereby authorized and directed to deliver said deed to the Property Director for further handling.
