BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized to execute, for and on behalf of The City of San Diego, a Tideland Use and Occupancy Permit with the SAN DIEGO UNIFIED PORT DISTRICT, which permit authorizes the San Diego Police Department to use approximately 14,560 square feet of Port District Tidelands directly across Kettner Boulevard from the Central Police Station and south of the Wosk Building, for vehicle parking for the San Diego Police Department, for a one year period at a monthly rental of \$245.00, under the terms and conditions set forth in the form of permit on file in the office of the City Clerk as Document No. 746161.

BE IT FURTHER RESOLVED, that the transfer of \$1,470.00 from the Unallocated Reserve to the Police Department, to provide rent for the balance of fiscal 1973-74, be and the same is hereby authorized and approved.
