

RESOLUTION NO. 209711 JAN 22 1974


WHEREAS, regulations for expenditure of Gas Tax funds for the Paradise Valley Road funding permit a maximum of 9% of the acquisition costs for incidental expenses in connection with acquisitions for right of way; and

WHEREAS, because of the necessity to condemn several parcels for this project, the incidental expenses totaled \$5,923.14 or 19% of the acquisition costs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the expenditure of \$3,220.89 from the Capital Outlay 245 Fund to reimburse the Gas Tax 220 fund for the cost of incidental expenses not allowable for the Paradise Valley Road funding be, and the same is hereby approved and authorized.
