Greason	PUBLIC WORKS DEPARTMENT Equipment Division	\$45	Some time ago this Equipment Mechanic suggested removing the radiator shutters on some packer trucks to prevent them clogging and causing overheating. The suggestion was first turned down, but later was found to be a good idea. It reduces breakdowns and maintenance on sanitation truck engines.
Ted N. Schroeder	PARK & RECREATION DEPT.	\$35	A plastic trash barrel that is rugged, light and more resistant to denting, and also more economical than the metal barrels being used, was suggested. These have been purchased by the Park Division for a saving of \$350 per year.
Bert L. Holmes	PUBLIC WORKS DEPARTMENT Sanitation Division	\$10	It was felt by this Utilityman II that collections from the San Diego Blood Bank were being made too frequently. Arrangements were made to reduce the number of collections without impairing the service. This saves about \$100 a year.
