

RESOLUTION NO. 209730 **JAN 24 1974**  
APPROVING MAP OF PENASQUITOS GLENS  
UNIT NO. 6 RESUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by THOMAS E. CRAIG, Registered Civil Engineer, and entitled "PENASQUITOS GLENS UNIT NO. 6 RESUBDIVISION Being a subdivision of Lot 341 of Penasquitos Glens Unit No. 6, according to the Map thereof No. 7003 filed in the office of the County Recorder of San Diego County, July 30, 1971; together with a portion of Lot No. 1 of Penasquitos Hills, according to Map thereof No. 6389, filed in the office of the County Recorder of San Diego County June 13, 1969, together with a portion of Madrigal Street as dedicated to public use, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Amalia Street, Carlota Street, Raju Street, Susita Street, Amalia Court, Susita Court, Susita Terrace and the walkway, for public purposes, and said streets and the walkway are hereby declared to be public streets and a public walkway and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction

and maintenance of water, sewer, drainage and general utility facilities; together with the emergency vehicle easement, all as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets and the walkway are accepted on behalf of the public as heretofore stated; and that those easements for the construction and maintenance of water, sewer, drainage and general utility facilities; together with the emergency vehicle easement, all as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
