


**RESOLUTION No. 209743**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$26,524.00 by Futura Enterprises, a partnership, for ADDITIONAL IMPROVEMENTS TO PRESIDIO PARK AND RECREATION CENTER in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 745533.
2. That the expenditure of \$28,000.00 is hereby authorized out of Park and Recreation Bond Fund (Fund No. 725) and that the expenditure of \$8,000.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for ADDITIONAL IMPROVEMENTS TO PRESIDIO PARK AND RECREATION CENTER in the City of San Diego and related costs.
