RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO,
CALIFORNIA, ORDERING CHANGES AND MODIFICATIONS IN
THE BOUNDARIES OF THE ASSESSMENT DISTRICT AND IN
THE ASSESSMENT

(Soledad Mountain Park District - Park
District No. 4)

WHEREAS, in proceedings under Division 8 of the San Diego Park District Procedural Ordinance of 1969, as amended, which incorporates by reference provisions of the Municipal Improvement Act of 1913 (commencing with Section 10000, Streets and Highways Code) the Council adopted its resolution of intention, Resolution No. 209037, ordering the City Manager to cause the Report required by said Act to be prepared, and pursuant thereto the City Manager caused said Report to be prepared, consisting of the description and depiction of the proposed acquisition, an estimate of the costs and expenses of said acquisition, a diagram showing the assessment district, and the proposed assessment of the costs and expenses of the proposed acquisition, said Report being on file with the City Clerk; and

WHEREAS, the Council adopted Resolution No. 209038 approving said Report, as filed, and appointing a time and place of hearing thereon; and

WHEREAS, on December 27, 1973, the Council adopted its Resolution No. 209542, declaring its intention to order changes

and modifications in the boundaries of the assessment district and in the assessment, and set a hearing thereon; and

WHEREAS, a hearing has been held on said proposed changes and modifications all in the manner and form prescribed by law, and this Council now having jurisdiction to order said changes and modifications,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

Section 1. That the public interest, convenience and necessity require certain changes and modifications in the boundaries of the assessment district and in the assessment, which changes and modifications are fully described and set forth in Resolution No. 209542, adopted by the Council on December 27, 1973, and the Council hereby orders said changes and modifications as set forth and referred to therein. The modifications of the boundaries of the assessment district are as shown and described on that certain amended map of the assessment district, designated "Plat No. 3862," consisting of 2 sheets, which indicates by a modified boundary line the extent of the territory to be included in the proposed district, which shall govern for all details as to the extent of the district. Said amended map is hereby approved, and reference is hereby made to said map for a description of the

district. The City Clerk is hereby authorized and directed to endorse and file said map in the manner as prescribed by Section 3113 of the Streets and Highways Code.
