

RESOLUTION NO. 209781 JAN 31 1974

APPROVING MAP OF LA JOLLA GOLF & TENNIS CLUB UNIT
NO. 1 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, Registered Civil Engineer, and entitled "LA JOLLA GOLF & TENNIS CLUB UNIT NO. 1 Being a subdivision of a portion of Pueblo Lot 1254 of Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to the Map thereof made by James Pascoe in 1870, filed in the office of the County Recorder of San Diego County, November 14, 1921, and known as Miscellaneous Map No. 36.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: portions of Soledad Mountain Road, for public purposes and said portions of street are hereby declared to be portions of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in paragraphs 1, 2 and 3 of the certificate signed by the Owners for sewer and drainage facilities, general utility purposes, and open space, as granted and shown on said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of street are accepted on behalf of the public as heretofore stated; and that those easements listed in paragraphs 1, 2, and 3 of the certificate signed by the Owners are accepted on behalf of The City of San Diego, a municipal corporation, all as above stated.

Said City Clerk is hereby authorized and directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
