
Adopted on JAN 31 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, a first amendment to the agreement with the legal firm of GRAY, CARY, AMES & FRYE for labor consultant services, to amend paragraphs 4 and 5 of said agreement which is on file in the office of the City Clerk as Document No. 739859, in accordance with the terms and conditions set forth in the form of first amendment to agreement on file in the office of the City Clerk as Document No. 746248.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of ten thousand dollars (\$10,000) within the 100 Fund from Unallocated Reserve (53.30) to Special Consulting Services (43.05) for the purpose of providing funds to be used solely and exclusively for the above services.
