

RESOLUTION NO. 209793 JAN 31 1974

WHEREAS, the Council of The City of San Diego approved the Old San Diego Architectural and Site Development Standards and Criteria on February 22, 1973, by Resolution No. 207413; and

WHEREAS, the said Standards and Criteria are on file in the office of the City Clerk as Document No. 742763; and


WHEREAS, the Old San Diego Planned District Review Board on August 14, 1973, adopted revised standards and criteria pertaining to Document No. 742763 which the Board found to be desirable in order to further promote the distinctive architectural character of Old San Diego; and

WHEREAS, the Standards and Criteria should be amended;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Old San Diego Architectural and Site Development Standards and Criteria on file in the office of the City Clerk as Document No. 742763, be and the same is hereby amended by substituting in place of page 23 thereof that document on file in the office of the City Clerk as Document No. 746219.

Roofs should have a minimum slope of $3\frac{1}{2}$ inch vertical to 12 inch horizontal, unless otherwise specifically approved by the Board. Clay tile used for roof covering shall be of a type known as Mission barrel tile. With the approval of the Board, roof tile known as Mission Type S, may be used provided that barrel tile is used at the exposed edges and eaves.

No mechanical equipment shall be visible from any angle or any height outside of the building.

Window sash and doors shall be constructed of wood, unless otherwise specifically approved by the Board.
