


RESOLUTION No. 209803

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$192,310.02 by Ameron, Inc., Pipe Lining Division, a corporation, for MORTAR LINING THE UNIVERSITY AVENUE PIPELINE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 744948.
2. That the expenditure of \$327,000.00 is hereby authorized out of the Water Revenue Fund (502) of the City of San Diego solely and exclusively for the purpose of providing funds for MORTAR LINING THE UNIVERSITY AVENUE PIPELINE in the City of San Diego, and related costs.
3. Authorizing the City Auditor and Comptroller to transfer \$77,000.00 within the Water Revenue Fund (502), from Unallocated Reserve (67.91-3495) to Construction Contract (67.58-3275) for MORTAR LINING THE UNIVERSITY AVENUE PIPELINE in the City of San Diego, and related costs.
