

**RESOLUTION No. 209806**


Adopted on JAN 31 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Clerk and City Attorney are hereby authorized to execute a stipulation re sewer and storm drain easements by which the owner of the property in question, to wit, Pacific View Construction Company, Inc. grants to the City of San Diego two easements over its real property for sewer purposes at no cost to the City and to Amantea, Hill and Timmins, a California partnership, an easement for drain purposes. A copy of said stipulation is on file in the office of the City Clerk as Document No. 746255.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to accept said sewer easements under the terms and conditions stated in said stipulation.
