APPROVING MAP OF MISSION VILLAGE UNIT NO. 24

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, and entitled "MISSION VILLAGE UNIT NO. 24 Being a subdivision of portions of Lots 9 and 10 in Block 3 and portions of Lots 1 and 2 in Block 4 of Rosedale, according to Map thereof No. 826, filed in the office of the County Recorder of San Diego County, January 21, 1897, together with Orange Avenue as closed and vacated to public use, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
