
Adopted on FEB 7 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the CITY OF ESCONDIDO to carry out a Demonstration Project involving the removal of salts from reclaimed waste water using the reverse osmosis method at the Southside Water Reclamation facility which is located in Escondido, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 746299.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$27,010 within Sewer Revenue Fund 506 from the Unallocated Reserve (Activity 68.91 - 3495) to Research (Activity 62.85 - \$12,306 to go into 1151 Personal Services and \$14,704 to go into 3299 Non-Personal Expense), and that expenditure of said funds is hereby authorized, solely and exclusively, for City's share of Fiscal 1974 costs.
