


RESOLUTION No. 209845

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That, due to the inability of The City of San Diego to obtain bids for gasoline when the same were sought, the Purchasing Agent of The City of San Diego be and he is hereby authorized and directed to purchase GASOLINE on the open market for the duration of the Federal Mandatory Petroleum Allocation Program; said purchases shall be made only at prices within the Cost of Living Council Guidelines. Purchases shall be made in amounts for which budgeted funds have been allocated.
