BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of a sum not to exceed \$4,600.00, be and the same is hereby authorized from Gas Tax Fund No. 220 solely and exclusively for the purpose of providing funds for the City's contribution and related expenses in connection with the improvements to MARKET STREET and SIXTH AVENUE under 1911 Act proceedings.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work to relocate existing street light and traffic signal services in conjunction with the above referenced project where required, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
