RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF SAN DIEGO AUTHORIZING THE
RECISSION OF A CONTRACT AWARDED FOR THE
IMPROVEMENT OF LOS ALTOS ROAD AND
RESCINDING RESOLUTION NO. 206619.

WHEREAS, this Council did on October 3, 1972, by
Resolution No. 206619, award a contract for the construction
and improvement of Los Altos Road pursuant to the 1911
Municipal Improvement Act to the R. E. Hazard Contracting
Co.; and

WHEREAS, both parties now mutually desire to rescind
said contract and the contractor has indicated in Exhibit A,
attached hereto and made a part hereof, his written consent
to said rescission; and


WHEREAS, construction has not yet commenced and it is
