RESOLUTION NO. 209961

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO DECLARING ITS INTENTION TO ORDER CHANGES AND MODIFICATIONS IN THE WORK PROPOSED TO BE DONE UNDER RESOLUTION OF INTENTION NO. 205383 IN THE MATTER OF THE IMPROVEMENT OF LOS ALTOS ROAD.

WHEREAS, this City Council did, on April 18, 1972, pursuant to the Municipal Improvement Act of 1911, adopt its Resolution of Intention No. 205383, declaring its intention to order the construction of certain improvements as more fully described therein, and on the plans, profiles and drawings therein referred to, and did provide for the costs of said work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, subsequent to said public hearing, this Council did order the improvements described in the above-referenced Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that certain changes and modifications be made in the proposed work to be done under said Resolution of Intention; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. That the public interest, convenience and necessity require and it is the intention of this Council to order the changes and modifications as more particularly

described and shown on City of San Diego Engineering Drawing No. 14277-2-D including "B" Change and Drawing No. 12994-B, consisting of two (2) sheets, filed in the office of the City Clerk as Document No. 746578, which are incorporated herein and which shall govern for all details thereof.

That the estimated decrease in the cost of the work by reason of the aforesaid proposed changes or modifications is the sum of \$513.39.

That, due to recent price increases, the estimate of the cost of the overall improvement is increased by a sum of \$9,793.44.

Section 2. NOTICE IS HEREBY GIVEN, that on THURSDAY, APRIL 11, 1974, at 8:30 o'clock a.m. in the Council Chambers of the City Administration Building, Community Concourse, 202 "C" Street, in the City of San Diego, California, are hereby fixed as the time and place when and where any and all persons having any objections to the proposed changes and modifications herein proposed may appear and show cause why said changes and modifications should not be done and carried out in accordance with this Resolution of Intention to Modify.

Section 3. That the Clerk of said City be and he is hereby directed to cause this Resolution of Intention to be published at least ten (10) days before the date of said hearing in the City's Official Newspaper, a daily newspaper published and circulated in said City and hereby designated for that purpose by the City Council.
