That the acceptance by the City Manager of that Deed of DONALD C. JACOBSON and AUDRIE P. JACOBSON, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of February 6, 1974, conveying to said City an easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lot 106 of Mission Heights, according to Map thereof No. 3142, filed in the office of the County Recorder of San Diego County, October 22, 1954, as more particularly described in said deed, be, and the same is hereby approved, and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named ULRIC STREET.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the County Recorder of San Diego County.

X That the expenditure of \$100.00 from Gas Tax Fund 220 is hereby authorized solely and exclusively to provide funds for the purchase of the above described property.
