

RESOLUTION No. 209970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Offer to Dedicate of SAN DIEGO TRUST & SAVINGS BANK as Trustee of its Trust P.T. 1469, and BASIC CONSTRUCTION PRODUCTS, INC., a California corporation, both executed in favor of The City of San Diego, bearing dates of December 18, 1973 and December 13, 1973, respectively, granting to said City a twenty-one year option to dedicate to public use for street purposes certain property described as the Northeasterly 5.00 feet of Lot 31, Boulevard Gardens, according to Map thereof No. 1505, filed in the San Diego County Recorder's Office, December 11, 1912, be, and the same are hereby accepted on the conditions therein expressed.

BE IT FURTHER RESOLVED, that by this acceptance the City does not dedicate to public use for street purposes the strip of land described in said instrument but reserves the right to so dedicate at a future time.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to file the foregoing said Offers to Dedicate in the office of the Recorder of San Diego County.
