

RESOLUTION No. 209973

Adopted on FEB 26 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Offer to Dedicate of JOHN J. SALE and FLORA JANE SALE, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of December 11, 1973, granting to said City a twenty-one year option to dedicate to public use for street purposes certain property described as the Northeasterly 5.00 feet of Lot 36, Boulevard Gardens, according to Map thereof No. 1505, filed in the San Diego County Recorder's Office, December 11, 1912, be, and the same is hereby accepted on the conditions therein expressed.

BE IT FURTHER RESOLVED, that by this acceptance the City does not dedicate to public use for street purposes the strip of land described in said instrument but reserves the right to so dedicate at a future time.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to file the foregoing said Offer to Dedicate in the office of the Recorder of San Diego County.
