


RESOLUTION No. 209977

Adopted on FEB 26 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$10,000 from Capital Outlay Fund 245, \$5,000 of which shall go into Brown Field Special Aviation Fund 239 and the remaining \$5,000 of which shall go into Montgomery Field Special Aviation Fund 240, and that said funds are provided, solely and exclusively, to match annual State contributions to each airport for capital improvements.
