BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the expenditure of a sum not to exceed \$18,000, be and the same is hereby authorized out of Capital Outlay Fund No. 245, solely and exclusively for the purpose of providing funds for the design and construction of miscellaneous capital improvements, as more particularly described and set forth in Document No. 746507, on file in the office of the City Clerk; said improvements to be made to the United States International University site for recreation and safety purposes.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above referenced construction of miscellaneous capital improvements and for miscellaneous fence and erosion repair, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.

BE IT FURTHER RESOLVED, that it be and it is hereby certified that the information contained in the Negative Declaration on file in the office of the City Clerk as E.Q.D. No. 73-8-008C has been completed in compliance with the California Environmental Quality Act of 1970 and the State guidelines pursuant thereto, and that said Negative Declaration has been reviewed and considered by this Council.
