BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to accept the proposal of PACIFIC TELEPHONE COMPANY to install a telephone system for the Police Communications Center, scheduled to begin operation August, 1974, as set forth in the form of proposal on file in the Office of the City Clerk as Document No. 746513.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to expend \$10,200 from Federal Revenue Sharing Fund 2383 and \$6,445 from Capital Outlay Fund 245 for the above purpose, and for the purchase of miscellaneous furnishings and equipment necessary to begin Police Communications Center operations in the new facility.
