

RESOLUTION NO. 210019

WHEREAS, the request for partial funding of the 1974 San Diego Crew Classic meets the requirements for city funding of such community events in that it both serves to promote The City of San Diego, and specifically Mission Bay, and is supported by its sponsors with matching cash contributions; and

WHEREAS, the 1973 San Diego Crew Classic provided a day long athletic spectacle of national importance to an estimated 15,000 San Diegans admission-free; and

WHEREAS, the 1973 San Diego Crew Classic did, in fact, receive national attention; and

WHEREAS, the 1974 San Diego Crew Classic will bring together the Eastern Intercollegiate Rowing champions from the University of Wisconsin, the crew from the United States Naval Academy, the Pacific Coast Championship crew from the University of Washington, the crew from San Diego State University and several other highly regarded crews for a rowing classic that promises to be an even more exciting and significant national rowing event; and

WHEREAS, it is appropriate that the 1974 San Diego Crew Classic be funded through and under the conditions of City's existing agreement with Mission Bay Associates; and

WHEREAS, it is necessary to amend said agreement with Mission Bay Associates to provide for not to exceed \$8,000.00 to be expended on a matching funds basis to support the 1974 Crew Classic; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that the City Manager be and he is hereby authorized and empowered
to execute, for and on behalf of said City, a First Amendment to
Agreement with MISSION BAY ASSOCIATES, a nonprofit California
corporation, to add sponsorship of the 1974 Crew Classic, under
the terms and conditions set forth in the form of First Amendment
to Agreement on file in the office of the City Clerk as Document
No. 746652.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed
\$8,000.00 from Transient Occupancy Tax Fund 223, contingency
reserves, is hereby authorized for the above stated purpose.

BE IT FURTHER RESOLVED, that Resolution No. 210018, adopted
February 28, 1974 is hereby rescinded.
