That the expenditure of \$10,700.00 is hereby authorized out of Gas Tax Fund (Fund No. 220) and that the expenditure of \$1,800.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CURVE CORRECTION IN FOOTHILL BOULEVARD BETWEEN TOURMALINE STREET AND VICKIE DRIVE in the City of San Diego, and related costs.
