

RESOLUTION NO. 210045 **MAR 5 1974**

WHEREAS, CUSH TOURS, INC., have applied to the City Council for a Certificate of Public Convenience and Necessity to operate automobiles for hire within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.13 of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates in part:

1. There is a demand for this kind of service. In the past, hotel patrons have made use of a free airport transportation provided by the hotels, although some have since discontinued this service.

2. The applicant is financially responsible and is recommended by financial and business institutions here in San Diego. Mr. Cushman is experienced in the transportation field as he now operates "Cush Tours, Inc.," which includes ground transportation and convention services; tours of Tiajuana through Mexcursions in conjunction with Mexi-Coach, which is regulated by the Interstate Commerce Commission; and Smedley's Towne Tours, which recently obtained three Certificates of Public Convenience and Necessity from the City Council on December 20, 1973.

3. The two vehicles proposed for use are 11-passenger Checker Model 1970 Aero buses. They will be inspected to conform with necessary state and local safety regulations prior to commencing operation.

4. The City Traffic Engineer reports that the proposed service will not have any effect upon traffic congestion and parking, and will not result in a greater hazard to the public.

5. The fares to be charged are within those rate limits prescribed by Section 72.21 of the Municipal Code.

WHEREAS, the Council this date, after a public hearing has found the contents of the City Manager's report to be correct in part; and

WHEREAS, the Council this date, after public hearing has found that a need exists for this service; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That having filed an application for a Certificate of Public Convenience and Necessity to operate two vehicles for hire pursuant to the provisions of Section 72.11 of the San Diego Municipal Code, and the City Manager having conducted the required investigation, the City Council, by a vote of 8 to 0, hereby approves a Certificate of Public Convenience and Necessity to Cush Tours, Inc., to operate the vehicles specified in the application upon the following express conditions:

1. The service shall be only from Atlas Hotels in Mission Valley to the San Diego International Airport and back; and
2. Statistical reports regarding the operation and passengers carried shall be filed with the City within one year from the date of this resolution.
