

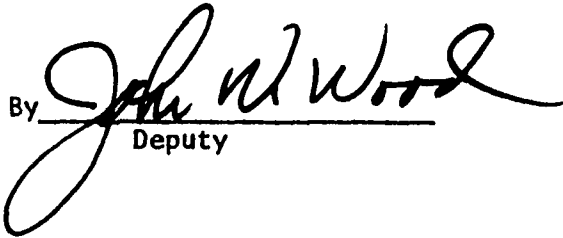
**RESOLUTION No. 210079**
