


RESOLUTION No. 210081

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$3,550.10 by Rick Stadelman, an individual, dba R.S. Construction Co., for the CONSTRUCTION OF STORM DRAIN IN LOTS 10 & 11, BLOCK G, REDLAND GARDENS EXTENSION in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 746143.
2. That the expenditure of \$2,265.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF STORM DRAIN IN LOTS 10 & 11, BLOCK G, REDLAND GARDENS EXTENSION in the City of San Diego, and related costs.
