

RESOLUTION NO. 210113

WHEREAS, The City of San Diego through its Police Department desires to undertake a research project, designated as Hazardous Situations Project, to develop procedures for handling extremely hazardous situations such as armed and barricaded suspects, kidnap-hostage situations, sniper-ambush incidents, VIP security, etc.; and

WHEREAS, such project will include the preparation of a detailed manual covering procedures encompassing such situations and the purchase of necessary equipment; and

WHEREAS, the California Council on Criminal Justice, herein called "CCCJ," has indicated that funds are available through the Omnibus Crime Control and Safe Streets Act of 1968, Public Law 90-355, as amended by Public Law 91-644, herein called "Safe Streets Act," administered by CCCJ; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager of The City of San Diego is hereby authorized, for and on behalf of said City, to submit a Grant Application for law enforcement purposes to CCCJ pursuant to the terms and conditions set forth in the form of Grant Application on file in the office of the City Clerk as Document No. 745794 and is further authorized to execute, for and on behalf of said City, a Grant Award Contract for law enforcement purposes including any extensions or amendments thereof and any subgrants pursuant thereto.


BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$5,226 from the Unallocated Reserve (53.30) to the Allocated Reserve (53.20) to be used solely and exclusively for the purpose of meeting the City's cash-match requirement as set forth in said grant application.

BE IT FURTHER RESOLVED, that grant funds received hereunder shall not be used to supplant on-going law enforcement expenditures.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered, to invite bids as necessary for items detailed in the Hazardous Situations Project Grant Application after the effective date of the grant contract, subject to the appropriate regulations of The City of San Diego.

BE IT FURTHER RESOLVED, that Resolution No. 209411 is hereby rescinded.
