WHEREAS, the Stephen Watts Kearny High School Basketball Team of 1974 has won the California Interscholastic Federation (CIF) San Diego County Championship after also winning their Western League Championship, the Kiwanis Tournament, and the University Tournament; and

WHEREAS, this feat was accomplished with a perfect, undefeated season of thirty-two games, such undefeated season having been achieved by only two other basketball teams in San Diego's history; and

WHEREAS, the Stephen Watts Kearny High School basketball team is the first Western League team ever to achieve an undefeated season; and

WHEREAS, four members of this team have been selected for the All League Team, two members have been selected to share the League's "Player of the Year" honor, and one member has been selected as CIF's "Most Valuable Player"; and

WHEREAS, this team may represent the best high school basketball team ever to play in San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Council wishes to recognize the Stephen Watts Kearny High School Basketball Team for its outstanding

achievement; does hereby declare its appreciation for the honor they have brought to San Diego; and desires to wish them continued success in the future.
