APPROVING MAP OF SCRIPPS CLINIC SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled "SCRIPPS CLINIC SUBDIVISION Being a subdivision of portion of Pueblo Lot 1326 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in the year 1870, a copy of which map was filed in the office of the San Diego County Recorder November 14, 1921, as Miscellaneous Map No. 36, in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements, with the right of ingress and egress, for the construction and maintenance of sewer and drainage facilities as granted on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; and that those certain

easements, with the right of ingress and egress, for the construction and maintenance of sewer and drainage facilities as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
