BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller be and he is hereby authorized and directed to transfer \$152,000 in unused Gas Tax Fund 220 to Gas Tax Fund Reserve to supplement the budget of other gas tax capital improvement projects; \$103,250 of said sum to be used for the purpose of supplementing the budget for the project entitled Miramar Road, from Carroll Road to I-15; the remainder of the \$152,000 sum to be used to supplement other gas tax improvement projects, as required.
