BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$32,496.65 is hereby authorized out of Flood Control and Storm Drain Bond Fund 727 of The City of San Diego, solely and exclusively for the purpose of providing funds for expenses in connection with the Mission Beach storm drain project, supplementing Resolution No. 203717.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$299,503.35 within Storm Drain Capital Improvement Project Fund 11-032(4) to Flood Control and Storm Drain Bond Fund 727 Reserve for the purpose of supplementing budgets of other flood control or storm drain projects, as required.
