

RESOLUTION NO. 210143 MAR 14 1974

A RESOLUTION ESTABLISHING A CENTRAL RELOCATION  
AGENCY IN THE CITY OF SAN DIEGO.

WHEREAS, The City of San Diego desires to promote uniformity of relocation assistance throughout the community and to coordinate relocation planning of all public entities within the City to assure that adequate relocation resources will be available prior to displacement of community residents; and

WHEREAS, state legislation, effective January 1, 1974, authorizes the City to create a Central Relocation Agency to coordinate and control the relocation activities of other public entities within the jurisdiction of the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. Under the authority of Section 7261.6 of the Government Code, there is hereby established in The City of San Diego a Central Relocation Agency to coordinate the relocation activities of other public entities within the jurisdiction of the City.

2. The City Manager is hereby authorized and directed to assume the obligations, powers, and responsibilities of the Central Relocation Agency as set forth in Section 7261.6 of the Government Code, and may assign said obligations, powers and responsibilities to an appropriate City department under his management and control.

3. Every public entity within the jurisdiction of the City shall file with the Central Relocation Agency the relocation rules and regulations which it is required to adopt pursuant to Section 7267.8, and shall file annually, its relocation plans by June 1 of each year for the subsequent fiscal year.

4. The Central Relocation Agency shall review the relocation plans of all public entities within the jurisdiction of the City of San Diego, in accordance with procedures set forth in Section 7261.6 of the Government Code.


5. Approval of relocation plans will require the affirmative action of the City Manager or his authorized designee. Approval will constitute a finding by the Agency that it has reasonable assurance that adequate relocation resources exist within the requirements of the law, which will be available at the times required by the plan.

6. If modification of a relocation plan submitted by a public entity is directed by the Central Relocation Agency, the public entity may appeal to the Relocation Appeals Board, established pursuant to Section 33417.5 of the Health and Safety Code.

7. The Central Relocation Agency shall coordinate the execution of each public entity's relocation plans and shall share with each public entity making request, the relocation information of all other public entities.

8. The Central Relocation Agency, through the City Manager with prior City Council approval, may contract with other entities to perform relocation and central relocation services.
