BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work for the connection of necessary utilities in conjunction with the lease of a mobile trailer from CHRISTIANA COMMUNITY BUILDERS in Tierrasanta for the operation of a City fire station, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract, at an estimated cost of \$2,600.00.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$2,600.00, be and the same is hereby authorized from Capital Outlay Fund No. 245 solely and exclusively for the purpose of providing funds for the use of City Forces as provided above.
