

RESOLUTION No. 210150

Adopted on MAR 14 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

This Council recommends that the City Manager and Planning Director recommend that their respective representatives on the Subdivision Review Board not support the imposition of a condition on tentative subdivision maps in that area of the City served by I-15/805 requiring that subdividers provide evidence of traffic capacity on said highways as a condition of final map approval.

BE IT FURTHER RESOLVED, that the City Manager is directed to complete a report to the Council on the subject of imposing such appropriate conditions in the future, including:

1. Guidelines on the means of implementing such recommendations as are made by the City Manager;
2. Outlining the information to be supplied by a subdivider, and suggesting a procedure for review of the data submitted.
