


RESOLUTION No. 210152

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$20,995.00 by Eugene R. Johnson, an Individual, for HIGHLAND-LANDIS PARK IMPROVEMENTS in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 745894.
2. That the expenditure of \$24,300.00 is hereby authorized out of Park and Recreation Fund (Fund No. 725); that the expenditure of \$200.00 is hereby authorized out of Park Service District Fund (Fund No. 630); and that the expenditure of \$3,000.00 is hereby authorized out of Capital Outlay Reserve Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for HIGHLAND-LANDIS PARK IMPROVEMENTS in the City of San Diego and related costs.
