

RESOLUTION NO. 210168 MAR 19 1974

WHEREAS, the California Council on Criminal Justice may consent to review for possible funding the project submitted by The City of San Diego referred to as "Crimes Against Property Control," on file in the Office of the City Clerk as Document No. 746767; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized to submit to the California Council on Criminal Justice on behalf of said City, the application for grant for law enforcement purposes including any extensions or amendments thereof.

BE IT FURTHER RESOLVED, that in the event the California Council on Criminal Justice consents to fund the above project, The City of San Diego agrees to accept the grant and designates the City Manager to execute, for and on behalf of said City, the contract for the grant for law enforcement purposes.

BE IT FURTHER RESOLVED, that The City of San Diego agrees to provide the required matching funds to said project.

BE IT FURTHER RESOLVED, that grant funds received hereunder shall not be used to supplant ongoing law enforcement expenditures.

BE IT FURTHER RESOLVED, that on or after the effective date of the grant contract, the City Manager is authorized to execute a contract for the services of a Research Assistant/Typist.

BE IT FURTHER RESOLVED, that the Police Department is authorized to use \$16,271 to meet the cash match requirements of this grant out of \$20,000 which will be requested in Fiscal Year 1975 Police Department Budget for the express purpose of meeting LEAA-CCCJ grant match requirements.
