

That the offer of McNaughton Book Service is hereby accepted and the City Manager is hereby authorized to execute a contract for MCNAUGHTON BOOK SERVICE for the period of one (1) year beginning April 1, 1974 through March 31, 1975 for a total cost of \$6,996.00; terms 2% for advance payment, plus sales tax with option to renew for four (4) additional one (1) year periods, prices firm for the first option year and subject to 10% escalation for each of the three (3) successive years.
