

RESOLUTION No. 210184

Adopted on MAR 21 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$125,577, \$19,000 and \$6,000 from Capital Outlay Fund 245, Water Revenue Fund 502 and Sewer Revenue Fund 506, respectively, of The City of San Diego, is hereby authorized solely and exclusively for the purpose of providing funds for the purchase and installation of a remote receiver system and microwave system components for the Police, Fire, Public Works and Water Utilities Departments.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the installation of base station receivers, cavity resonators, antennas and microwave components, pursuant to the recommendation of the City Manager and submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
