


RESOLUTION No. 210191

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$41,960.00 by Sapper Construction Company, a corporation, for the construction of MISSION BAY ATHLETIC AREA - ADDITIONAL TENNIS COURTS in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the specifications on file in the office of the City Clerk as Document No.745891.
2. That the expenditure of \$23,500.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245), Cooperative Park Projects of the City of San Diego solely and exclusively for the purpose of providing funds for the construction of MISSION BAY ATHLETIC AREA - ADDITIONAL TENNIS COURTS in the City of San Diego, and related costs.
3. That the contribution of \$1,500.00 from the Pacific Beach Tennis Club to be used for the above purpose is hereby accepted.
