

RESOLUTION NO. 210199 MAR 21 1974

WHEREAS, the City Council of The City of San Diego desires to assure compliance with the reporting requirements for the increase in allowable flag drop rate for cab operators occasioned by increased costs of gasoline; and

WHEREAS, this resolution is to amend Resolution No. 210013 in order to enforce compliance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That failure on the part of any cab operator to comply with the requirements as set forth in Resolution No. 210013 may result in the suspension or revocation of that particular cab operator's certificate of public convenience and necessity if deemed warranted by the Council pursuant to Section 72.01(k)(5). Any cab operator found to have submitted information pursuant to Resolution No. 210013 which is intentionally false or misleading shall be subject to having said cab operator's certificate of public convenience and necessity revoked pursuant to Section 72.01(k)(5).
