


RESOLUTION No. 210200

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$7,128.00 by Alco Fence Company, Inc., a corporation, for MISSION BAY PARK WILDLIFE REFUGE FENCE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 746391.
2. That the expenditure of \$9,000.00 is hereby authorized out of the Park and Recreation Bond Fund (725) Reserve of the City of San Diego solely and exclusively for the purpose of providing funds for MISSION BAY PARK WILDLIFE REFUGE FENCE, in the City of San Diego, and related costs.
3. That it be and it is hereby certified that the information contained in the Negative Declaration prepared by the City of San Diego, a copy of which is on file in the office of the City Clerk of the City of San Diego as E.Q.D. No. 73-12-008C, has been reviewed and considered by this Council.
