

**RESOLUTION No. 210212**

Adopted on MAR 26 1974


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the delivery of that instrument entitled Offer to Dedicate, executed by SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, in favor of The City of San Diego, bearing date of March 1, 1974, offering to dedicate to public use for street purposes described as a portion of Lot 78 of Rancho Mission of San Diego, a portion of Lot 8 of The Highlands and a portion of unnamed street (vacated) Map 284, as more particularly described in said instrument, be, and the same is hereby accepted on the conditions therein expressed.

BE IT FURTHER RESOLVED, that by this acceptance of delivery, the City does not dedicate to public use for street purposes the portions of land described in said instrument but reserves the right to accept said offer to so dedicate at a future time.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to file the foregoing said offer to dedicate in the office of the Recorder of San Diego County.
